

## Rules for the Use of the WBIC IT system

- No person or persons shall use the WBIC computer network without due authorization from the WBIC administrator.
- 2. Every allocation of WBIC-IT resources shall be made on the understanding that it is to be used only for the purposes for which it was requested and only by the person to whom the request was made. Passwords are not to be shared under any circumstances.
- 3. No person shall connect hardware to the WBIC-RS data network without proper authority
- 4. No user of WBIC-IT shall, by a willful or deliberate act, jeopardize the integrity or security of WBIC-IT hardware, system programmes or other stored information.
- 5. Every person authorized to use WBIC-IT facilities shall be expected to treat as privileged, any information not provided by or generated by him or herself, which my become available, by their use of WBIC-IT. No such information may be copied, modified or disseminated or used in any part without the permission of the appropriate person or body.
- 6. No person shall use WBIC-IT facilities to hold or process personal data except in accordance with the provisions of the Data Protection Act.
- 7. No person shall download, disseminate or otherwise transfer scanner data without due authorization, and, where authorization is given, the transfer is to be done on the understanding that is done in accordance with the Data Protection Act.
- 8. If any person is believed to be in breach of any of the above rules, their WBIC-IT account will be disabled, and the breach will be reported to a Faculty of Medicine disciplinary hearing.
